Section 2-342: Powers and Duties.

The corporation counsel shall:

(1) Suits and actions: Prosecute and/or defend any and all suits or actions at law or equity to which the town may be a party, or in which it may be interested, or which may be brought against, or by, any officer of the town, or in the capacity of such persons as an officer of the town; settlement lawsuits and claims against the town, its agents and officials and employees; settle lawsuits or claims prosecuted in the name of or on behalf of the town or its officials and settle lawsuits, demands, actions at law or equity and/or claims on behalf of the town, town officials(s), town agents(s) and/or town employees(s), without the express authority of the president or the board of trustees if the settlement amount does not exceed \$10,000.00\$\$\frac{5}{20,000.00}\$, within 30 days of any such settlement the town attorney shall report the nature and terms of the settlement to the president and the board of trustees.
