President Dominick opened the meeting to the public for their comments.

Public Relations Director Ray Hanania reported on the December 8th multi-dwelling fire that left several families homeless and thanked the Town & its residents for their quick response to provide aide to the victims. He highlighted on how the Town Chaplain Ismael Vargas & Director of Mental Health/General Assistance Carolyn Arias overseen the swift distribution of donations to the victims and their assistance in finding them immediate temporary shelter.

Town Chaplain Vargas, also, highlighted on how the Town as a whole came together; from donations of clothing and necessities, to the many Parent Patrol volunteers that came to their aide in sorting and prepping of all the donations to make ready for distribution. He reported on how the Clergy Committee too, came to the aide by providing 2 to 3 families each, additional services. Town Chaplain Vargas thanked Town Clerk Punzo-Arias for being there and showing support.

Trustee Porod commended Town Chaplain Vargas and Director of Mental Health/General Assistance Arias on a job well done in helping the victims of the fire and noted that they not only helped the victims but their pets as well.

Trustee Vargas thanked Town Chaplain Vargas and Director of Mental Health / General Assistance Arias for their service and congratulated Public Relation Director Hanania in getting the news coverage for the clothes drive.

Resident Ernestine Charles thanked President Dominick and Mrs. Dominick for the services provided to the seniors.

Resident Frank Kraut thanked the Town for their efforts in getting the help for those residents effected by the recent summer flood and fire. He, also, thanked Senior Services Department(s) for their generosity.

Resident Steve Waldenga reported on December 7th, an app on his phone alerted him three (3) times that Israel was being bombed by Hamas and appreciated that the Town had the flags half-mast.

President Dominick thanked the Cicero Fire Dept. for the handling and taking care of three (3) fires that had occurred in a matter of eleven (11) days. He, also, thanked the Cicero Police Dept. for the arrest of one (1) of six (6) men involved in the multitude of armed robberies taking place throughout the city and suburbs.
