President Dominick opened the meeting to the public for their comments.

Trustee Reitz announced vehicle tag applications will be going out this week and the side door off of 50th Avenue will be open to vehicle tag sales only; signage will be posted. She also noted receiving complaints concerning mechanics parking vehicles in the public way.

Town Clerk Punzo-Arias thanked the Board for passage of the FEMA Assistance Proclamation and reported receiving calls from residents inquiring on the Town's Flood Control program.

Public Relations Director Hanania highlighted on the collaboration between Trustee Cundari, Police Superintendent Chlada and Senior Activities Director Dominick in organizing the birthday parades for kids: 15 & under and seniors.

Business License Director Vargas reported on the progress of business license renewals, its collaboration with the Cicero Health Department and State Department of Commerce guidelines on re-opening non-essential & essential businesses. He also reported delivery on June 1st, 275 boxes of food to assist families affected by the pandemic and 300 plus families whom picked up.

Various Members of the Board inquired from the Legal Department and Emergency Operations Committee about the re-opening guidelines for outdoor eating, for businesses along Cicero Avenue, the wearing of masks vs face shields and the Town's dog park permits.

Town Clerk Punzo-Arias reported on the COVID-19 testing event held over the weekend at the Community Park and thanked Health Director Grazzini, Howard Brown, the Cicero Police Dept. and Chaplain Vargas for their participations.

Trustee Reitz directed Public Works to remove certain green zone signage near and around 3300 block of 61st Court & Lombard which was recently decreased by ordinance.

Town Attorney Del Galdo announced receiving notification from Rush University Medical that they will be terminating the Mobile Stroke Unit agreement which has been non-staffed since March due to the COVID-19 Pandemic.

Trustee Cundari requested the EOC to send out mailers with updates on the COVID-19 Pandemic; now that businesses will be allowed to reopen.
