#### (Purpose of Ordinance)

(The purpose of this ordinance is to amend the Policy to be used by Town Department Heads or their designees when purchasing products or services for the Town, to take all necessary steps to carry out and effectuate the guidelines of the Policy and to amend Chapter 2, Section 2-2 of the Town Code to reflect such change)

Section 2-2: Authorizing for purchase of supplies.

It is declared to be unlawful for any Town official or Town employee to purchase supplies or articles of any kind for the Town, in an amount equal to or greater than ten <u>fifteen</u> thousand and no/100 U.S. dollars (\$10,000.00) (\$15,000.00), without such purchase having been previously authorized by the Town President and the Board of Trustees. It shall be the sole duty of each Town Department Head to ensure that there are adequate funds in their department's budget prior to carrying out any purchase.
