Trustee Cundari addressed the audience expressing his support of President Dominick and his decision to drafted the pending legislation in regards to hours of operation for liquor licenses for the Town.

("O" 27-24)

On motion of Trustee Virruso seconded by Trustee Porod, the Ordinance amending Chapter 10, Section 10-58 of the Code of Ordinances of the Town of Cicero, Illinois regarding hours of operation for liquor licenses for the Town, was accepted, placed on file and approved for passage by the following vote:

(Purpose of Ordinance)

(The purpose of this ordinance is to amend Chapter 10, Section 10-58 of the Town Code as set forth herein and to authorize the Town President to take any and all action necessary.)

Section 10-58: Classes designated; fees; number limited.

(a) Classes A and AA licenses. Under this article, classes A and AA licenses shall be subject to the following:

. . .

(2) Class AA licenses shall authorize the retail sale on the specified premises of all alcoholic beverages for consumption on the premises, as well as other retail sales of such alcoholic beverages where such premises are operated as hotels, motels, restaurants or bowling alleys. The annual fee for such license shall be \$3,000.00. There shall be no more than 45 class AA licenses issued within the corporate limits of the town. Class AA licenses authorize entertainment on the premises only as set forth in section 10-72 of this Code.

In addition to and in no way in limitation of the foregoing, the following restrictions shall apply to the retail sale of alcoholic beverages in restaurants: (1) the premises shall consist of a minimum of 1,400 square feet of space that is open to or usable by the general public during business hours for food service and dining purposes; (2) 50 percent or more of the gross revenue in any month from the operation of the licensed premises must be from the sale and service of meals; (3) no food or alcoholic liquor, as defined in section 10-1, shall be sold, given away, offered for sale, served or dispensed on or about the premises or place of business licensed under this section between the hours of 2:00 12:00 a.m. and 8:00 a.m., Monday through Saturday of each week, and between the hours of 3:00 12:00 a.m. and 11:00 a.m. on Sunday of each week, and each licensee shall ensure the licensed premises are free of all patrons no later than 15 minutes after the close of business on the day in question; and (4) the service of alcoholic liquor shall be only during the time that food is prepared on the licensed premises and is available to be served to patrons and a menu is in effect. Such a menu shall be presented to each patron as they are seated or be posted in such a manner as to be easily readable by the patrons of the restaurant, except when the restaurant is being used to host a catered private function.

In addition to and in no way in limitation of the foregoing, the following restrictions shall apply to restaurants wherein there is a barroom where cocktails are served where such barroom is segregated from the main dining area and/or seating area: (1) the seating area of the barroom shall only encompass an area up to 25 percent of the seating area of the restaurant; (2) there shall be no difference in the pricing for food and beverages served in the barroom area and the restaurant and/or dining area; and (3) that the service of alcoholic beverages in the barroom shall be only during the time that food is prepared on the licensed premises and is available to be served to patrons and a menu is in effect.

. . .

(c) Class A-B and class AAB licenses. Class A-B and class AAB licenses shall be subject to the following:

. . .

(3) A New Liquor License Applicant seeking a class A-B license on and after the effective date of this Subsection shall not be issued a class A-B license unless: (a) the original package portion of the licensed premises is physically separate from the consumption portion of the licensed premises; (b) the original package portion of the licensed premises is a minimum of 1,500 square feet in area; and (c) the consumption portion of the licensed premises is a minimum of 1,500 square feet in area. A New Liquor License Applicant seeking a class AAB license on or after the effective date of this Subsection shall not be issued a class AAB license unless: (i) the original package portion of the licensed premises is physically separate from the consumption portion of the licensed premises; and (ii) the original package portion of the licensed premises is a minimum of 1,500 square feet in area.

For purposes of this Subsection "New Liquor License Applicant" shall mean a liquor license applicant applying for a class AAB or class AAB license for the first time or a liquor licensee reapplying for a class A-B or class AAB license because his, her or its class A-B or class AAB license application was denied or because his, her or its class A-B or class AAB license was revoked or forfeited, whether due to cessation of business or for other reasons. A "New Liquor License Applicant" shall not include: (1) a liquor licensee that was issued a class A-B or class AAB license prior to the effective date of this Subsection, provided that the liquor licensee renews said license on an annual basis in accordance with the provisions of this Code and the license is not revoked or forfeited; (2) a liquor licensee that is applying for a class A-B or class AAB license due to a change in the location of the licensed premises, provided said premises had a valid class A-B or class AAB license immediately before the change in the ownership of the licensed premises, provided that the licensed premises had a valid class A-B or class AAB license due to a change in the ownership of the licensed premises, provided that the licensed premises had a valid class A-B or class AAB license immediately before the change in ownership.

No alcoholic liquor shall be sold, given away, offered for sale, served or dispensed on or about the premises or place of business between the hours of 12:00 a.m. and 8:00 a.m., Monday through Saturday of each week, and between the hours of 12:00 a.m. and 11:00 a.m. on Sunday of each week.

(cc) Class C. A class C license permits the retail sale of beer and wine for consumption only on the premises where it is sold and not for resale, in a video gaming cafe where food is available for purchase and consumption on the premises. The annual fee for such license shall be \$5,000.00. Notwithstanding any provision of this Code to the contrary, the total number of class C licenses shall not exceed 40.

In addition to and in no way in limitation of the foregoing, the following restrictions shall apply to the retail sale of alcoholic beverages in video gaming cafes:

. .

(3) No food or alcoholic liquor, as defined in section 10-1, shall be sold, given away, offered for sale, served or dispensed on or about the premises or place of business licensed under this section between the hours of 12:00 a.m. and 11:00 a.m. on Sunday, 12:00 a.m. and 8:00 a.m. Monday through Friday, and between 12:00 a.m. and 8:00 a.m. on Saturday of each week, and each licensee shall ensure the licensed premises are free of all patrons no later than 15 minutes after the close of business on the day in question; and

. . .

(cc-a) Class C-A. A class C-A license permits the retail sale of beer and wine for consumption only on the premises where it is sold and not for resale, in a video gaming café where liquor and gaming are an auxiliary use in a business which the primary use of the business includes the sale of packaged or prepared foods except that candy and ice cream shall not be considered packaged foods for the purposes of this section. The applicant and license holder must hold a valid and current business license issued by the town at the time of application

for or renewal of the license. The annual fee for such license shall be \$5,000.00. Notwithstanding any provision of this Code to the contrary, the total number of class C-A licenses shall not exceed 40.

In addition to and in no way in limitation of the foregoing, the following restrictions shall apply to the retail sale of alcoholic beverages in auxiliary video gaming cafés:

. . .

(3) No alcoholic liquor, as defined in section 10-1, shall be sold, given away, offered for sale, served or dispensed on or about the premises or place of business licensed under this section between the hours of 12:00 a.m. and 11:00 a.m. on Sunday, 12:00 a.m. and 8:00 a.m. Monday through Friday, and between 12:00 a.m. and 8:00 a.m. on Saturday of each week, and the primary business must be in full operation and all products of the primary business shall be available for sale during the hours of operation when liquor consumption and video gaming are available; and

. . .

(d) Class D licenses. A class D license shall authorize the sale or giving away of alcoholic liquor by clubs to their bona fide members or their guests, at regular or special meetings, for consumption on the premises. The annual fee for such license which shall authorize the sale or giving away of all alcoholic liquors shall be \$1,000.00. There shall be no more than four class D licenses issued within the corporate limits of the town. (Also see class I regulations.)

No alcoholic liquor may be sold, given away, offered for sale, served or dispensed on or about the premises or place of business between the hours of 12:00 a.m. and 8:00 a.m., Monday through Saturday of each week, and between the hours of 12:00 a.m. and 11:00 a.m. on Sunday of each week.

. . .

(ff) Class FF license. A class FF license shall authorize the sale or giving away of all alcoholic liquors, for consumption on the premises only, by establishments operated as public places of seated entertainment, as a restaurant, and having a capacity of 600 persons but not more than 800 persons. Class FF licenses are authorized to provide seated entertainment between the hours of 8:00 a.m. and 12:00 a.m. Class FF licenses must be located on Cermak Road, Cicero Avenue, Ogden Avenue, Roosevelt Road or Laramie Avenue. The annual fee for such license shall be \$3,500.00.

No alcoholic liquor may be sold, given away, offered for sale, served or dispensed on or about the premises or place of business between the hours of 12:00 a.m. and 8:00 a.m., Monday through Saturday of each week, and between the hours of 12:00 a.m. and 11:00 a.m. on Sunday of each week.

. . .

(g) Class G license. A class G license shall authorize the sale or giving away of all alcoholic liquors by establishments operated solely for the purpose of banquets or other specific events as defined in Section 10-1 of this Code where such establishment is providing the facilities for such events and is supplying the alcoholic liquor to be sold or given away in such establishment. The annual fee for such license shall be \$1,625.00. No alcoholic liquor may be sold, given away, offered for sale, served or dispensed on or about the premises or place of business between the hours of 12:00 a.m. and 8:00 a.m., Monday through Saturday of each week, and between the hours of 12:00 a.m. and 11:00 a.m. on Sunday of each week.

Section 50-32: Personnel Designated As Police Officers.

The members of the Department of Police who shall be known as and are designated as police officers are the Superintendent of Police, the First Deputy Superintendent of Police, three Deputy Superintendents, the Assistant Deputy Superintendent of Patrol, the Director of Training and Education, the Crime Victims Assistance Director, the Commander of Detectives, three Captains and such number of Lieutenants, Sergeants and Patrol Officers as are set forth in the annual appropriation ordinance, and these members shall constitute the police force. Notwithstanding the foregoing, the Deputy Superintendent of the Gang Crimes Unit shall be a non-sworn, civilian position, and shall not be designated a police officer.

President Dominick opened the meeting to the public for their comments.

Owner of Hacienda Calavera, Louisa Valdez, expressed concerns with the new liquor license ordinance. President Dominick noted it was deemed necessary after continual complaints from residents and for the safety of responding Police officers. He added that it will go into effect as January 1, 2025.

Evelia Rodriguez, property owner of 5305 W. Cermak, expressed concerns with a possible vacant building due to the passage of the recent liquor ordinance.

Owner of Victoria's Bar, Diana Sanchez, expressed concerns with daytime criminal activity in the surrounding area of her business.

Owner of Langostino's Grill, Laura Rangel expressed support for the businesses.

Superintendent of Police Thomas Boyle reported on the number of hours and manpower which are continually exhausted on responding to calls of disturbances in the late night hours. He noted the notices the businesses have received are dram shop notices and his office is open to discuss such matters. Supt. Boyle also reported on a recent homicide committed by a bar patron, who resides outside of Cicero.

Superintendent Boyle reported going out to Springfield, IL on May 2nd, to honor fallen Patrolman John Kane, who lost his life after attempting to arrest three subjects who had just robbed a saloon on November 12, 1910 and attending a similar ceremony with Cook County.

Town Clerk Punzo-Arias addressed those in attendance and stated, "We as elected officials have a responsibility not only with our business owners, but also for the safety of our town residents. I will reemphasize what President Dominick said, we do not want to hurt any liquor business establishments, and we want to see all businesses do well; I personally received many videos and/or complaints from residents who have complained about different incidents involving bars (fights, shootings, amongst other illegal activities), within our town who have witnessed and do not feel safe in their neighborhood."

Trustee Vargas thanked President Dominick for his continued support of the residents of Cicero and its Police officers, introduced a visiting official of Durango, MX and expressed her concerns of the short notice that was given to business owners regarding the recent legislation that took effect today. President Dominick informed her that the Ordinance would not go into effect until January 1, 2025 and would only be enforced if the establishments do not comply. He also said that a meeting would take place with liquor licensed establishments soon.

Resident Ernestine Soto thanked the Town Board, Senior Activities Director Diana Dominick and her staff for the Senior Mother's Day event and for making it so special.

President Dominick reported on the success of the Cinco De Mayo Festival and announced that it was Firefighter Appreciation Day on May $4^{\rm th}$ & Professional Municipal Clerks Week on May $5^{\rm th}-11^{\rm th}$.

Community Development Block Grant Director, Mr. Tom Tomschin congratulated the Town Board for the Town of Cicero being awarded half a million dollars from the Morton Arboretum USDA Urban and Community Forestry Service Grant.

On motion of Trustee Virruso seconded by Trustee Garcia, the board then stood adjourned at 10:47 A.M. to meet on Tuesday, May 28, 2024 at 10:00 A.M., in the Town Hall, Town of Cicero.
