INSTRUCTIONS:

1. NO MORE THAN FIVE (5) LICENSED ANIMALS SHALL BE HOUSED OR MAINTAINED IN ANY RESIDENCE, BUSINESS, OR APARTMENT WITHIN THE TOWN.
2. ALL PETS IN THE TOWN MUST HAVE A PET TAG BY NOVEMBER 30, 2025 TO AVOID A LATE FEE.
3. TAGS PURCHASED AFTER NOVEMBER 30, 2025 ARE SUBJECT TO A \$10.00 LATE FEE.
4. PET TAGS CAN BE PURCHASED IN PERSON AT THE COLLECTOR'S OFFICE.
